Hon. Mr. GOERTZEN moved:

THAT the House do now proceed to the Orders of the Day.

And the Question being put. It was agreed to.

During Orders of the Day, Hon. Mr. FLETCHER rose on a Matter of Privilege alleging that the Provincial Government misled the House about the nature of Interim Supply and the functions of government budget processes and moved:

THAT a committee of the Legislature be struck to provide government MLAs tutorial and remedial education starting with the Manitoba grade 5 curriculum on our Westminster system of government. And provide suggestions on watching Canadian news rather than American news.

And Hon. Mr. GOERTZEN, Ms. FONTAINE, Hon. Mr. GERRARD and Mr. SARAN having spoken.

WHEREUPON Madam Speaker ruled there was no Matter of Privilege.

Subsequently during Orders of the Day, Hon. Mr. FLETCHER rose on a point of order alleging that the Provincial Government made false statements about the nature of Interim Supply and the functions of government budget processes.

And Hon. Mr. GOERTZEN having spoken to the point of order,

WHEREUPON Madam Speaker ruled that there was no point of order.

The House resumed the debate on the Proposed Motion of Hon. Mr. FIELDING:

THAT Bill (No. 28) – The Interim Appropriation Act, 2019/Loi de 2019 portant affectation anticipée de crédits, reported from Committee of the Whole, be concurred in and be now read for a Third Time and passed.
