**THRONE SPEECH PROCEDURE
FIFTH SESSION OF THE FORTY-SECOND LEGISLATURE
NOVEMBER 15, 2022**

1. Her Honour, the Lieutenant Governor, the Honorary Aide-de-camp, the Premier, the Acting Administrator and the Private Secretary meet in the Lieutenant Governor's reception room.
2. **All Members of the Legislative Assembly** proceed to their seats in the Chamber and **remain standing**. All **Members of the Legislative Assembly** participating virtually must **remain seated**.
3. At 1:30 p.m. the Sergeant-at-Arms followed by the Speaker, the Clerk, the Deputy Clerk, the Clerk Assistant and the Pages enter the Chamber.
4. The Drummer drums as Her Honour, the Lieutenant Governor accompanied by the Honorary Aide-de-camp, the Premier, the Chief Justice and the Private Secretary enters the Chamber and takes her seat on the Throne.
5. The Private Secretary delivers the Throne Speech to Her Honour, the Lieutenant Governor.
6. Her Honour, the Lieutenant Governor will say, "**PLEASE BE SEATED**" and then reads the Throne Speech.
7. After completion of the Throne Speech, Her Honour, the Lieutenant Governor will rise from the Throne to retire, accompanied by the Honorary Aide-de-camp, the Premier, the Provincial Court Judges, the Private Secretary and the Drummer.

ALL MEMBERS STANDING.

Prior to exiting the Chamber, "God Save the King" and "O Canada" will be sung.

8. The Speaker proceeds to the Throne and reads the Prayer and the Land Acknowledgement.
9. The Premier moves:

"THAT Bill (No. 1) – An Act respecting the Administration of Oaths of Office/Loi sur la prestation des serments d'entrée en fonction, be now read a First Time."
10. The Premier moves:

"THAT the Speech of Her Honour, the Lieutenant Governor, be taken into consideration tomorrow."
11. The Premier moves:

"THAT this House do now adjourn."
12. **ALL MEMBERS STANDING.**

The Speaker, preceded by the Sergeant-at-Arms and followed by the Clerks and Pages, exits the Chamber.
