Dear Krystal,

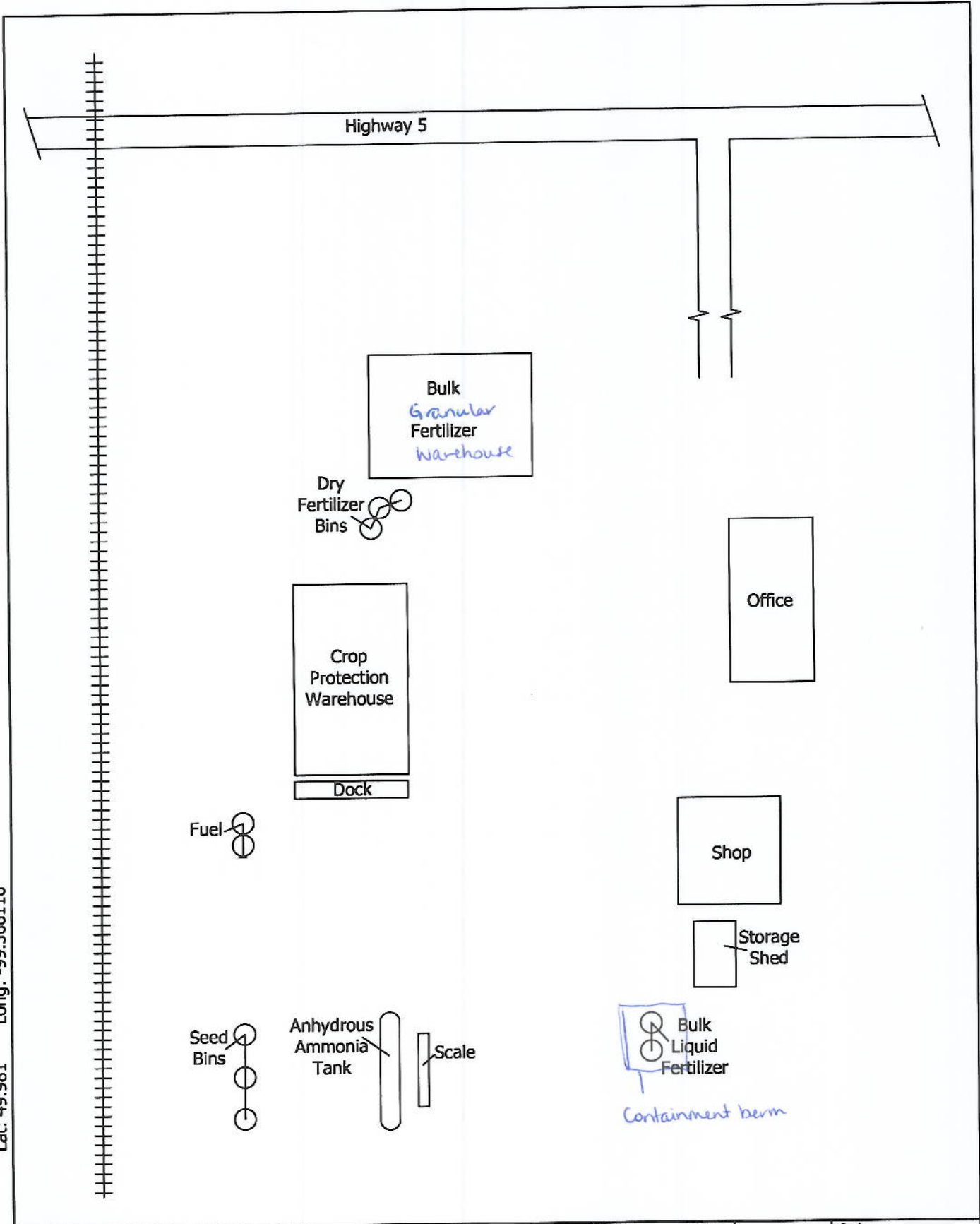
In light of the recent acquisition of the ag retail locations from Viterro Inc., please change the legal name of the Environment Act License 1974 R for Carberry, MB to Crop Production Services (Canada) Inc.

While License 1974 R shows that the facility was licensed to operate a crop protection products warehouse, bulk granular fertilizer, anhydrous ammonia storage, and distribution facilities, legacy companies added bulk liquid fertilizer storage and a mobile seed treatment plant which has been in operation for a number of years. At this time, we would like to notify you that Crop Production Services (Canada) Inc. plans to continue to sell bulk liquid fertilizer and to conduct seed treatment operations from this location.

The total liquid fertilizer capacity for the site is 40 tonnes which is stored in liquid fertilizer tanks, all of which are located within secondary containment. The mobile seed treatment operation is conducted using a seed treater that is attached to a portable auger; all contained within a portable containment berm.
