Further to my earlier correspondence, please find attached a letter dated 27 May 2016 entitled "Amendment to 69 HW RR License for GFL Environmental Inc., Winnipeg Location."

The current application revision GFL is seeking is to direct discharge its treated effluent from the effluent storage tank within its Water Treatment Building to the City of Winnipeg Municipal system. Currently, GFL is trucking the effluent from the effluent tank in the Water Treatment Building to the City of Winnipeg Municipal System. This change will save GFL trucking cost in delivering the treated effluent to the Municipal Plant. GFL has attained price estimates from certified contractors in Winnipeg to complete the installation of a sewer connection from the Winnipeg main line to the GFL Water Treatment Building.
