Please find comments below as regards EAP for RM Russell-Binscarth 5832.10

1. Wildlife and Fisheries Branch SD

Be advised that there is known occurrences of rare and endangered species located throughout the study area region. These include occurrences for Smooth Blue Beard-tongue near Russell, Chestnut-collared longspur near Rossburn, and rare grassland birds in the area (Wood pewee, bobolink, and barn swallow) as well. The establishment of the water line locations will have impact on nesting locations


Proponent to contact the conservation Data Center Chris Friesen (204 945-7747) to determine actual occurrences in the study area of rare, endangered, or threatened species in the study area and also possible mitigation plan that could be implemented.

Manitoba Infrastructure (MI) has reviewed the proposal under the *Environment Act* noted above and has the following concerns/comments associated with the proposed development:

1. The proponent should be informed that, under the Highways Protection Act, any new, modified or relocated access connection onto a PTH will require a permit from Highway Traffic Board for PTH's (Including change in use). A permit may also be required for:
 - Any construction (above or below ground level) within 38.1 m (125 ft) of the right of way PTH 16, 45 & 83.
2. The proponent should be informed that, under the Highways and Transportation Act, any new, modified or relocated access connection onto a PR will require a permit from Manitoba Infrastructure. A permit may also be required for:
 - Any construction (above or below ground level) within 38.1 m (125 ft) of the right of way of PR 264, PR 366, PR 476, PR 478 and PA 668 (03668010HU); or
 - Any plantings within 15.2 m (50 ft) from the edge of the right of way of PTH 16, PTH 45, PTH 83, PR 264, PR 366, PR 476, PR 478 and PA 668 (03668010HU); or
 - Discharge of water or other liquid materials into the ditch on PTH 16, PTH 45, PTH 83, PR 264, PR 366, PR 476, PR 478 and PA 668 (03668010HU).
3. Where the proposed water lines will be within highway right-of-way along and across PTH 16, PTH 45, PTH 83, PR 366, PR 476, PR 478 and PA 668 (03668010HU) an underground utility agreement will be required.
